TO: All Contractors Signatory to the **Voice-Data-Video Agreement**
 between the Northern Illinois Chapter, NECA and Local Union 364, IBEW

RE: Increase in Wage Package effective June 1, 2014

Please be advised that effective June 1, 2014 through May 31, 2015 the wage and fringe benefit package for Technicians under the Voice-Data-Video Agreement will change as follows:

Base Wage - increase by \$0.56 to \$37.00
 Local Pension - increase by \$0.70 to \$11.70

Additionally, fringe benefits based on percentage amounts will change accordingly. The new Voice-Data-Video wage package effective June 1, 2014 through May 31, 2015 is as follows:
